- 1. RISK CATEGORY I (POLE BARNS, STORAGE BUILDINGS) SHALL BE CONSTRUCTED TO 120 MPH.
- 2. RISK CATEGORY II (MOST RESIDENTIAL, SMALL COMMERCIAL) SHALL BE CONSTRUCTED TO 130 MPH.
- 3. RISK CATEGORY III (LARGE ASSEMBLY COMMERCIAL) SHALL BE CONSTRUCTED TO 140 MPH.
- 4. RISK CATEGORY IV (HOSPITALS, EMERGENCY SERVICES) SHALL BE CONSTRUCTED TO 140 MPH.
- 5. NO AREA OF ALACHUA COUNTY IS IN A WIND-BORNE DEBRIS REGION.

LICENSING: Structural, Roofing, Plumbing, Electrical, Mechanical and Gas contractors shall meet State of Florida and Alachua County licensing requirements.
