#### **INTRODUCTION**

The Envision Alachua Sector Plan Amendment (EASP) provides an alternative strategy and policy structure for meeting Alachua County's Comprehensive Planning Goals, Planning Principles (where adopted) and Objectives which is based upon the opportunity to provide long-term planning for conservation, development, and agriculture on a landscape scale for a substantial geographic area due to the current ownership pattern. This amendment provides diligent and careful attention to the comprehensive planning philosophy and policies of Alachua County in the preparation of this amendment and to facilitate protection of regionally significant resources, including, but not limited to, regionally significant water courses and wildlife corridors; ensuring the adequate mitigation of impacts to applicable regional resources and facilities, including those within the jurisdiction of other local governments, as would otherwise be provided.

This analysis describes how this amendment is consistent with the Alachua County Comprehensive Plan (ACCP) and identifies the relationship of the proposed text amendments to the existing goals, objectives and policies in the ACCP.

#### **FUTURE LAND USE ELEMENT**

The Objectives and Policies of the Alachua County Future Land Use Element (FLUE) are consistent with four (4) land use planning principles adopted as a part of the FLUE Goal. The FLUE also includes three (3) land use strategies as a means and method to achieving these principles throughout Alachua County. This amendment introduces a fourth (4<sup>th</sup>) land use strategy that would also meet these principles focusing on the creation of major economic opportunities at a size and scale that would accommodate community desired economic uses that cannot currently be accommodated by the adopted Alachua County Future Land Use Map, when such economic development is provided in combination with the protection and retention of regionally significant lands for conservation, habitat protection and wildlife connectivity and a conservation-first strategy to protect water supply.

The EASP and this Plan Amendment is consistent with each of the FLUE Principles by providing an alternative set of Objectives and Policies that are expressly formulated to

address the size, scale, location and greenfield nature of the property. These Objectives and Policies expressly support the 4 FLUE Principles as follows:

**PRINCIPLE 1.** PROMOTE SUSTAINABLE LAND DEVELOPMENT THAT PROVIDES FOR A BALANCE OF ECONOMIC OPPORTUNITY, SOCIAL EQUITY INCLUDING ENVIRONMENTAL JUSTICE, AND PROTECTION OF THE NATURAL ENVIRONMENT.

- The amendment provides large-scale sites for research, education and employment uses consistent with the local and regional needs to support the growing innovation economy;
- The amendment provides for the concentration of future development in specific areas and the location of conservation lands in a manner that will contribute to regional conservation linkages; and
- The amendment provides for the provision of significant areas for conservation in a manner that protects high value ecological resources based upon their contribution to regional landscape linkages, contiguity with existing conservation lands, and the opportunity to contribute to the conservation and enhancement of natural resources, community watersheds, and natural preserves.

**PRINCIPLE 2.** BASE NEW DEVELOPMENT UPON THE PROVISION OF NECESSARY SERVICES AND INFRASTRUCTURE. FOCUS URBAN DEVELOPMENT IN A CLEARLY DEFINED AREA AND STRENGTHEN THE SEPARATION OF RURAL AND URBAN USES.

- The amendment leverages existing local and regional assets to create economic progress opportunities in support of nearby population centers that are in need of additional jobs. These assets include but are not limited to:
  - University of Florida, Sante Fe College, and other educational institutions;
  - Existing rail infrastructure;
  - Existing highway infrastructure, particularly the access provided by SR 20, SR 24, SR 26, and US 301;
  - Shands and other healthcare facilities;
  - Existing Silviculture and Agriculture; and
- The amendment provides for the protection of conservation lands and the use of compatible land use or buffer transitions to protect and separate urban uses along the development edge from adjacent rural uses.

**PRINCIPLE 3.** RECOGNIZE RESIDENTIAL NEIGHBORHOODS AS A COLLECTIVE ASSET FOR ALL RESIDENTS OF THECOUNTY.

 The amendment protects and enhances Rural Clusters by maintaining the permitted uses, densities and standards provided in the Rural/Agricultural land use category in

- effect on the date of adoption of the EASP Plan Amendment on lands adjacent to the Rural Clusters.
- The amendment enhances the communities of Hawthorne and East Gainesville by providing job opportunities in close proximity to the residents of Hawthorne and East Gainesville.

# **PRINCIPLE 4.** CREATE AND PROMOTE COHESIVE COMMUNITIES THAT PROVIDE FOR A FULL RANGE AND MIX OF LAND USES.

- The amendment provides for an approval process that prohibits Detailed Specific Area Plans with single use residential within the Employment Oriented Mixed Use land use district and establishes an appropriate mix of uses; and
- The amendment provides for the use of an integrated development pattern that is sized to minimize walking distance between the majority of residential uses and employment opportunities within the Planning Area. This development pattern shall be connected and organized by a system of corridors that support compact urban form, and connected, pedestrian-friendly communities.

The EASP embraces the multi-modal transportation system focus of the Transportation Mobility Element (TME) and introduces specific policies and standards that will provide for increased mobility between residential areas and employment opportunities.

The EASP and this Plan Amendment is consistent with each of the TME Principles by providing an alternative set of Objectives, Policies and specific standards that are expressly formulated to ensure enhanced mobility and accessibility between the residential areas of the existing communities of Hawthorne and East Gainesville, any future residential areas within the EASP and the new employment opportunities being created through this amendment. These Objectives and Policies expressly support the 4 TME Principles for Automobile, Bicycle and Pedestrian Circulation as follows:

**PRINCIPLE 1**. TO ESTABLISH AND MAINTAIN A SAFE, CONVENIENT, AND EFFICIENT AUTOMOBILE, TRANSIT, BICYCLE AND PEDESTRIAN TRANSPORTATION SYSTEM, CAPABLE OF MOVING PEOPLE AND GOODS THROUGHOUT THE COUNTY.

 The amendment includes specific functional placemaking components within the EA-EOMU to achieve land use and public facility efficiencies, including the reduction of per capita greenhouse gas emissions and vehicular trips on external roadways.

**PRINCIPLE 2.** TO REDUCE VEHICLE MILES OF TRAVEL AND PER CAPITA GREEN HOUSE GAS EMISSIONS THROUGH THE PROVISION OF MOBILITY WITHIN COMPACT, MIXED-USE, INTERCONNECTED DEVELOPMENTS THAT PROMOTE WALKING AND BICYCLING, ALLOW FOR THE INTERNAL CAPTURE OF VEHICULAR TRIPS AND PROVIDE THE DENSITIES AND INTENSITIES NEEDED TO SUPPORT TRANSIT.

- The amendment provides for a mixed-use development where the urban uses are limited to one mixed-use land use district, EA-EOMU. This land use district includes a specific mix of uses that is designed to support the creation of large-scale employment opportunities that will create jobs for the existing residents and communities of East Alachua County and includes standards to insure that the timing and phasing of development promotes internal circulation and a jobs to housing balance.
- The amendment provides for a specific locational standard for residential uses
  within the urban mixed use district of EA-EOMU to ensure that a majority of housing
  (with the exception of the Hawthorne Reserve Area) is within a 1/2 mile walk of nonretail employment uses.

 The amendment provides for the use of an integrated development pattern that is sized to minimize walking distance between the majority of residential uses and employment opportunities within the Planning Area. This development pattern shall be connected and organized by a system of corridors that support compact urban form, and connected, pedestrian-friendly communities.

**PRINCIPLE 3**. DISCOURAGE SPRAWL AND ENCOURAGE THE EFFICIENT USE OF THE URBAN CLUSTER BY DIRECTING NEW DEVELOPMENT AND INFRASTRUCTURE TO AREAS WHERE MOBILITY CAN BE PROVIDED VIA MULTIPLE MODES OF TRANSPORTATION.

- The amendment supports new land use patterns through the Sector Planning
  process and incorporates specific development policies and standards that
  concentrate development in key areas and that conserve significant natural lands as
  EA-CON and as RBOS preventing Urban Sprawl through this creation of compact,
  mixed-use development.
- The amendment has been created of a sufficient size, population and land use composition to support a variety of economic and social activities consistent with an urban area designation. The amendment includes basic economic activities; all major land use categories, including agricultural and industrial; and a centrally provided full range of public facilities and services that demonstrates internal trip capture.
- The amendment includes a range of non-residential uses and a proactive strategy to generate and attract jobs, and provides a place where residents can both live and work, and achieve a better jobs and housing balance. This focus on a diversity of land uses, including employment opportunities, increases internal capture rates and thereby decreasing total trips.
- The amendment provides for a specific standards for the location of employment uses within the EA-EOMU that will ensure that a majority of jobs created shall be located within a 1/2 mile walk of future transit access for a transit connection to east Gainesville or Hawthorne.

PRINCIPLE 4. PROVIDE AN ALTERNATIVE TO CONVENTIONAL TRANSPORTATION CONCURRENCY WITHIN THE URBAN CLUSTER THAT RECOGNIZES THAT CONGESTION IS ACCEPTED IN GROWING URBAN AREAS, SO LONG AS VIABLE ALTERNATIVE MODES OF TRANSPORTATION ARE PROVIDED THAT SERVE TRAVEL DEMAND ALONG CONGESTED CORRIDORS. CONGESTION ALONG SOME ROADWAYS IS THE TRADEOFF BETWEEN ADDING ROADWAY CAPACITY ON CONGESTED CORRIDORS AND DEVELOPING AN INTERCONNECTED NETWORK OF ROADWAYS, BICYCLE AND PEDESTRIAN FACILITIES AND DEDICATED TRANSIT LANES SERVED BY EFFICIENT TRANSIT SERVICE.

#### STORMWATER ELEMENT

The EASP and this Plan Amendment is consistent with the Stormwater Element and provide policy amendments that clarify the current practice associated with implementing the County's Stormwater Element.

Specifically, the amendment recognizes that Floodplain and Flood prone areas within the EASP are currently defined by the Federal Emergency Management Agency (FEMA), and specifically the Zone "A" special flood hazard areas (SFHAs) shown on the effective Flood Insurance Rate Maps (FIRMs). The SFHAs within the EASP will be refined by their physical and hydrologic characteristics as determined by best available data, including but not limited to, LiDAR topography (contours), drainage studies, and other professionally acceptable determinants.

The EASP permits development within the 100-year floodplain to the extent that it does not result in adverse impacts as measured by an increase in peak stage or discharge outside of the EASP boundary. Compensating storage areas may be utilized on an EASP-wide basis to mitigate the potential for adverse impacts that could occur as a result of an increase in peak stage or discharge outside of the EASP boundary.

#### CONSERVATION AND OPEN SPACE ELEMENT

The policies of the Conservation and Open Space Element are applicable to the EA-AG, EA-CON and EA-RUR Land Uses. The EASP provides alternate policies for EA-EOMU Land Use because the existing policies do not anticipate development parcels on the scale of the EASP that can offer solutions that protect and enhance large natural systems of wetlands and uplands, rather than just protecting each wetland. Because the Urban Cluster has no large parcels that encompass landscape scale wetland ecosystems, the existing policies reflect protection of each wetland regardless of size. The EASP as a whole, and each DSAP individually, is of sufficient size to allow solutions that maximize natural system benefits while accommodating new EOMU development that may include impacting some wetlands while preserving and enhancing large wetland ecosystems including uplands. To protect the integrity of the policy structure of the existing Plan, the EASP proposes that wetland acreage and function within the EA-EOMU shall be protected through compliance with state and federal environmental permitting requirements, and further protected from potential development impacts by buffers with minimum widths established in the existing Plan. The state and federal protections require applicants first seek to avoid adverse impacts, then to minimize adverse impacts, and then to mitigate adverse impacts, similar to the requirements in the existing Plan; however, these agencies to not address isolated wetlands less than one half acre in size, whereas the existing plan regulates wetlands of all sizes.

For the EA-EOMU designated areas, this Plan Amendment is consistent with Conservation and Open Space Goal "To conserve, manage and restore or enhance the natural and human-related resources of Alachua County to ensure long-term environmental quality for the future" by providing an alternative set of Objectives and Policies that are expressly formulated to address the size, scale, location and opportunities for regional resource protection available to this property. This amendment represents a rare chance to design for ecological sustainability at a regional scale, thereby reducing landscape fragmentation, conserving ecosystem integrity, and providing a framework within which to design a compact urban footprint and incorporate infrastructure efficiently. This approach is consistent with the Alachua County Environmental Protection Department's mission "To protect the natural and historic resources of Alachua County and reduce environmental impacts of land development through environmental planning..."

The amendment provides specific natural resource protection and development standards as part of the proposed map amendment and text amendment that considers the broader regional landscape setting within which the lands occur; protects key environmental linkages in the regional landscape through the adoption of an Envision Alachua Conservation Land Use (EA-CON) designation over 46,051 acres of land and requires an additional 30% open space (15% of which is to be Resource Based Open

Space (RBOS)) within the urban mixed use district of EA-EOMU. In addition, the amendment requires that a management plan be prepared for the EA-CON and RBOS lands.

The compact development form of the EASP that is required within the EA-EOMU will preserve open space, maintain the largest contiguous wetland areas practicable, and minimize water and energy use. This development form and the open space protection policies of this amendment will help protect water quality by reducing the amount of paved surfaces and by allowing natural lands to filter runoff before reaching wetlands and surface waters. Additionally, compact communities optimize pedestrian, bicycle, and public transit which can reduce air pollution by reducing automobile mileage and traffic. Therefore, the numerous public benefits of compact development, together with protection of larger natural systems, may necessitate the federal and state permitting of wetland impacts required during implementation of the EASP over the next 50 years.

The location of the employment-oriented mixed use, agricultural, rural, and conservation land use categories were carefully selected as the preferred alternative for optimal suitability while providing minimal impact to the surrounding green infrastructure.

#### RECREATION ELEMENT

The EASP and this plan amendment are consistent with and further the goal of the Recreation Element by prioritizing access to a variety of recreational amenity types by requiring that the all residential uses within the EA-EOMU are within a ¼ mile walking distance of recreation/open space/conservation lands. With an overarching goal of achieving walkable community design, the EASP requires a network of "complete streets" to promote walking, prioritize pedestrians and cyclists, and provide recreational space.

In addition to the other conservation lands provided within the EASP, there is also a requirement that 30% of the EA-EOMU be set aside for open space uses, and requires that half of that open space (or 15% of all EA-EOMU lands) be protected as Resource Based Open Space (RBOS) as a means to further protect and enhance environmental systems. RBOS lands are required to have a public access plan for trails, boardwalks, and environmental education areas, and for passive recreational use where appropriate.

The EASP plan amendment does not include any objectives or policies that are in direct or indirect conflict with the goal of the Recreation Element, or any objective or policy associated with this goal. To the extent that the objectives and policies of the Recreation Element are applicable to any other land development application in Alachua County, they are applicable to development within the EASP.

The EASP and this Plan Amendment is consistent with the Goal of the Capital Improvements Element by providing an alternative set of Policies to address the multimodal transportation system focus of the EASP which introduces specific policies and standards that provide for increased mobility between residential areas and employment opportunities. This includes the addition of an EA Mobility District. The proposed policy amendments to the CIE are consistent with and reflect the amendments proposed for the Transportation Mobility Element.

The EASP Objectives and Policies expressly support the CIE Goal as follows:

**GOAL:** PROVIDE AND MAINTAIN, IN A TIMELY AND EFFICIENT MANNER, ADEQUATE PUBLIC FACILITIES FOR BOTH EXISTING AND FUTURE POPULATIONS, CONSISTENT WITH AVAILABLE FINANCIAL RESOURCES.

As a Sector Plan, DSAPs are the method of implementation and they provide the specific details regarding the development program, design standards, and public infrastructure impacts and requirements, as defined by FS 163.3245. Each DSAP guides conservation and development activities in the portion of the Planning Area to which it applies. The EASP plan amendment identifies that the funding for capital and operating costs for the required infrastructure for the EASP shall be assured, in part, through establishment of one or more Community Development Districts (CDDs) or other appropriate funding mechanisms within the EASP. The plan amendment also requires a developer's agreement between the County and developer of the site prior to approval of a Development Plan, addressing details of the development-phasing schedule and the level of the funding commitments of the CDDs, or other appropriate funding mechanisms.

The designation of funding for capital improvements to other public facilities needed to extend urban services into the EA-EOMU urban land use category shall be incorporated into the five-year capital improvement program of the Alachua County Capital Improvement Element following the approval of each DSAP.

#### **ECONOMIC ELEMENT**

The EASP and this plan amendment are consistent with and further the goal of the Economic Element by enhancing the economic prosperity of all citizens of Alachua County and expanding and diversifying the county's tax base through the addition of 15.5 million square feet of non-residential uses and is projected to generate an estimated 18,000 – 24,000 R&D/Office/Institutional jobs and 6,000-12,000 Advanced Manufacturing jobs over 50 years. The amendment is sized to include the provision of large-scale sites for research, education and employment uses consistent with the local and regional needs to support the growing innovation economy. The amendment links these jobs to available workforce by requiring that a majority of the residential uses within the EA-EOMU, excluding those residential uses with the Hawthorne Reserve Area, are within a 1/2 mile radius of non-retail employment uses and that a majority of jobs created within the EA-EOMU will be located within a 1/2 mile walk of future transit access for a transit connection to east Gainesville or Hawthorne.

community watersheds, and natural preserves; and the concentration of future development in specific areas and the location of conservation lands in a manner that will contribute to regional conservation linkages.
